Whether it's senior transportation or affordable housing, the Council on Aging is a trusted information and referral hub for older adults and caregivers, and a convener and catalyst for creative solutions to unmet needs. Here's a snapshot of our impact in 2018 and a look ahead at our 2019 priorities.

HERE'S HOW WE HELP

A great grandmother living in the Nations called COA for help after receiving our *Directory of Services* from St. Luke's Community House. Facing a rent increase of \$400 a month while raising her great grandchild, she was very concerned that her Section 8 appeal for an increase was denied. The great grandmother didn't know where to turn. Advocating on her behalf, we immediately contacted Metro Social Services to connect her with housing assistance. MSS agreed to assign a social worker to help her find new affordable housing.



2018 COMMUNITY IMPACT

From health care to affordable housing, the network of senior services is complex. COA's *Directory of Services* is the only comprehensive and impartial listing of services and community resources for older adults, caregivers and professionals in Middle TN. In 2018, COA worked with countless community partners to make updates and enhancements for the release of the 20th edition.

CONVENER & CATALYST

- Selected as a **Salute to Excellence finalist** for the Frist Foundation Team Building Award for convening the Senior Leadership Transportation Coalition and launching a new nonprofit, Senior Ride Nashville. We continue to support SRN and the launch of Senior Ride Sumner.
- Completed nine month Innovation Catalyst program to create an eldercare solution for employers and their employee caregivers
- Convened a collaborative, multi-agency work group, Middle TN Elder Watch, dedicated to preventing elder abuse and scams and protecting vulnerable older adults

HERE'S HOW WE HELP

Through our relationship with Nashville-based The Little Pantry That Could, an organization serving more than 200 families each week, we learned about an older client who was a victim of fraud. The client had given her money to a non-relative who promised to pay her bills for her. Instead, the non-relative spent the money, stole the client's identity and opened numerous credit cards in her name. Her electricity was turned off and she did not have money for food. We helped connect The Little Pantry That Could and their client with Adult Protective Services, Metro Police and emergency assistance agencies to restore this older woman's electricity and provide her with emergency financial assistance for her upcoming bills.

- Honored six older adults and Alive Hospice for outstanding service at the Sage Awards, for a total of 98 older adults honored over the past 27 years
- Garnered more than 80 news articles that address needs and issues important to older adults
- Consulted with and supported Urban Housing Solutions in securing tax credits for an affordable senior housing project at 26th and Clarksville
- Conducted advocacy on elder abuse, health care and social programs as part of the statewide Coalition for Better Aging
